## TOURNAMENT RULES AND REGULATIONS

1. Tournament is open only to bowlers certified in the Westchester County USBC Assn.
2. USBC Rules and Regulations will govern all bowling.
3. The tournament directors shall have the power to decide upon any matters pertaining to the operation of the tournament.
4. Mixed teams will be permitted in the team and mixed doubles events, but boys and girls will compete in separate divisions in the singles and regular doubles. All groups will bowl 3 games per event.
5. Multiple participation will be allowed in all four events. Teams will be required to change at least two bowlers to be eligible for re-entry. Doubles and mixed doubles will be required to change partners to be eligible for re-entry. Singles re-entries will be allowed, but bowler will be eligible for only one award.
6. AVERAGE DIVISIONS FOR TEAM EVENT: Class "A" 641 thru 880, Class "B" 640 and under

AVERAGE DIVISIONS FOR SINGLES: Boys: Class "A" 161 thru 220, Class "B" 160 and under
Girls: (One Class Only) 220 \& Under
AVERAGE DIVISION FOR REGULAR DOUBLES: (Both partners same gender)
Boys: Class "A" 321 thru 440, Class "B" 320 and under
Girls: (One Class Only) 440 and under
MIXED DOUBLES (1 boy and 1 girl) One division 440 and under
7. Entrants will use their highest certified league average or their Westchester County Jr. Bowling Tour average as of January 1st, 2024 based on a minimum of 12 games. Association members who do not have the required number of games must assume an 220 average and bowl in appropriate class.
8. Falsification of average on an entry for may result in the disqualification of the contestant and/or team.
9. League instructors or coaches shall be responsible for the verification of averages of contestants who bowl in more than one WCUSBC certified league.
10. Coaches or instructors are responsible for the certification of averages and USBC membership and MUST SIGN THE ENTRY FORM and submit copy of Jan. 1, 2024 League Standing Sheet to Tournament Director.
11. Handicaps will be $85 \%$ to the top of class for each event.
12. Teams and doubles events will be bowled in order listed on entry form. Substitutes will be permitted. The substitute must take the line-up position of the contestant being replaced. Substitutes must report to the tournament office one (1) hour before scheduled squad time and must provide average certification as per rule 7 .
13. Tardy bowlers must begin the event in the frame being bowled at the time of arrival. No pins for frames missed. No absentee scores.
14. No refunds will be made unless the cancellation is made at least 24 hours before the scheduled squad time.
15. Any appeal or protest regarding scores must be made in writing to the tournament directors within 72 hours after the error has occurred. Any appeal or protest regarding eligibility or general playing rules must be submitted as per USBC rule \#20.
16. Net and gross champions shall be named in each class of this tournament. Trophies will be awarded for every 20 entries in each class. In the case of a tie where awards are involved, duplicate awards will be made.
17. Entries will be honored in order in which they are received. The committee will attempt to honor all 1st choice of squad dates and times. NO ENTRY WILL BE ACCEPTED WITHOUT ENTRY FEES (checks or money orders).
18. ALL EVENTS REQUIREMENTS: all bowlers are eligible for this award, provided they participate in the team, singles, doubles or mixed doubles events. First appearance in team, singles, doubles, or mixed doubles (WHICHEVER IS BOWLED FIRST) will count towards the All Events standing. Net and gross awards will be made to the bowlers whose combined scores are the highest. There shall be one class only and all bowlers will be handicapped to 220.
19. Bowlers competing in this championship tournament will receive 1 WCJBT point for each squad bowled. 5 points will be awarded for each 1st place finish regardless of the event. (In order to receive WCJBT bonus points at the end of the season, a bowler must have bowled at least once in each of the events scheduled - Teams, Singles, Regular or Mixed Doubles).
20. Walk-ons will be permitted if space is available. Bowler(s) must report to the tournament office One (1) hour prior to desired squad and must provide average certification as per rule 7 .

ACKNOWLEDGMENTS WILL NOT BE SENT. Unless otherwise notified entrants will receive 1st choice of date and squad. Any Bounced Check to Tournament will incur a $\$ 35$ bank fee.
